

# £640,000 boost to the North West's museum collections

London, 4<sup>th</sup> April 2006 – Seven museums in the North West are benefiting from funding to enhance their collections, which are among some of the most important in the country. The Museums, Libraries and Archives Council (MLA) is making the awards from its Designation Challenge Fund to ensure that these outstanding collections can be enjoyed and appreciated by as many people as possible.

Details of the successful applicants in the North West are as follows:

- Lancashire County Museum Service has been awarded £98,500 to produce a virtual
  exhibition celebrating post-war developments within the Lancashire Textile Industry. The
  project will tell previously untold stories about the more recent past of the industry such
  as the importance of workforce migration from the Indian subcontinent.
- Manchester City Galleries will be using its grant of £100,000 to appoint a Community Interpretation Officer who will work with community groups to explore the many meanings behind the gallery's fine, decorative art and costume collections. The project will encourage users to see the collections as something that belongs to them and it will produce a series of online resources, displays and events.
- The Museum of Science and Industry in Manchester has been awarded £98,940 to
  bring to life its collections of things used or made by the people of the North West. The
  'Histories Revealed' project will collect personal stories behind the items it collected
  before the 1990s and make these stories available to everyone through online resources
  and travelling exhibitions.
- The People's History Museum will be spending £89,600 to create a temporary exhibition on the Growth of British Democracy 1800-2000. It will interpret the progress of reform as it affected the lives of the British working people and objects not previously seen by the public will be researched, conserved and exhibited through collaboration with the other museums in Manchester and further afield.
- Whitworth Art Gallery, at the University of Manchester has been awarded £59,000 to
  explore the textile pattern books assembled at Thomas Wardle's Printworks in Leeks and
  offer new insights into the working processes of late nineteenth century designers,
  retailers and manufacturers. The notes are very important, including records of dye
  experiments carried out for William Morris. The fragile books themselves will be made
  available for users online, using innovative book-browsing technology.
- The Wordsworth Trust has been awarded £93,672 to explore the role of women contained in the books, letters, journals and art that forms the Trust's outstanding holdings. 500 letters and 750 paintings will be digitised and made available online with the ability to view interactive information about the writers and hear sounds files of the original poems and songs. The new research will contribute to a touring exhibition, talks, workshops and family activities.
- The Boat Museum, Ellesmere Port is one of three museums in the Waterways Trust that will benefit from a grant of £100,000, in a project that will give new life to old boats. Eighty historic vessels in the collection are in need of conservation assessment, research and innovative interpretation. The fascinating histories of these 80 vessels will be researched and the resulting information will be digitised and available online and in the National Waterway Museum's galleries.

In total thirty-four projects across England are benefiting from £3million worth of funding. This has been made available through MLA's Renaissance programme to transform England's regional museums. All of the projects will build on the recommendations of the Museums Association's *Collections for the Future* report.

Chris Batt, Chief Executive of the Museums, Libraries and Archives Council explains: "MLA's vision for the future of England's museums is of places where everyone can be inspired to learn and to enjoy these fantastic collections. Our role is to encourage museums to exploit fully the possibilities for these collections, exploring innovative ways to reach audiences whether in the local community or beyond. I am delighted that MLA can continue to give direct financial support to North West museums through Renaissance."

Mark Taylor, Director of the Museums Association added, "These awards will shed new light on some of England's most important museum collections, enabling many more people to enjoy them through new displays and exhibitions, on the web and through outreach events. Over the years, the Designation Challenge Fund has done much to help people engage with collections of national significance and I am delighted that, this year, the Fund has focused on the recommendations of *Collections for the Future*. These awards are a vital step forward in helping museums to realise the potential of their collections more fully."

Renaissance is the first central government investment programme of its kind, aiming to make the collections of regional museums more closely connected with local communities.

### MLA

### **The Designation Scheme**

The Designation Scheme, managed by MLA, aims to identify and celebrate the best museum, library and archive collections in England; those that are deemed to be of outstanding national and international importance. The Scheme recognises that organisations with Designated collections care for a significant part of England's cultural heritage.

#### Renaissance

**Renaissance** is a national scheme to transform England's regional museums, led by the Museums, Libraries and Archives Council. By 2008, £150 million will have gone to help regional museums across the country raise standards and deliver real results in support of education, learning, community development and economic regeneration.

Renaissance affects the entire museums sector. A network of 'Hubs' has been set up in each English region to act as flagship museums and promote good practice. Alongside the Hubs, Regional Agencies and Museum Development Officers are providing advice and support, Subject Specialist Networks have been set up, and national museums are sharing their skills and collections.
